

**RENEWAL BY E-MAIL (POSSIBLE ONLY IF YOU HAVE A VALID ID CARD AND ITS PIN CODES)**

You can apply for the documents by means of an e-mail, if less than 5 years have passed since applying for the previous passport and capturing fingerprints, and if **You have a possibility to sign your application form digitally (PIN2).**

**To apply, you will need:**

1. [Application form](#)
2. [Additional application form](#) (if a child)
3. Digital photo (sent by email to [ppa@politsei.ee](mailto:ppa@politsei.ee). Please see the [requirements](#))  
Digital colour photo (**minimum resolution 1300 x 1600 pixels**) in .JPG format
4. Signature image (at least **200x600 pixels**) must be submitted in .JPG format. **Signature image must be written on an empty A4 paper**, scanned into computer or photographed with a mobile phone and added into container. Signature sample must be written in an evenly strong dark line.
5. Confirmation of your State fee payment

**Sign all your documents digitally in one container.**

**Payment by bank transfer from a bank located in a foreign country**

When the state fee is paid from a bank located in a foreign state, then the receipt of the transferred sum on the recipient's account may take 2 weeks. While effecting payment of the state fee from a bank located in a foreign country, it is necessary to know, in addition to the abovementioned, also BIC-code or SWIFT-code of the bank located in Estonia.

- The BIC i.e. SWIFT code of the SEB is EEUHEE2X.
- The BIC i.e. SWIFT code of the Swedbank is HABAE2X.
- The BIC i.e. SWIFT code of the Luminor Bank is NDEAEE2X
